This addendum is incorporating the following questions and answers into the above-referenced Invitation for Bid – Best Value.

1.0 The Following questions were either submitted in writing or by fax by one or more vendors. Each question (Q) is followed by its answer (A).

- Q1. On the bid sheet, Section 0600, line item numbers 33 and 56 are for repair of proximity gear - the cost to replace triple trim on the coat and pants, but proximity gear does not have triple trim. Can we exclude pricing on these items?
- A1. Yes, please do not provide pricing for these items as they are not applicable to proximity gear. Vendors may do so by leaving the space blank or noting "N/A".
- Q2. On the bid sheet, Section 0600, the section entitled "Alterations and Miscellaneous Repairs" does not have a separate pricing line for 'restitch' and 'rip and restitch'. Also, there are times where there may be an item or service that is not listed on the bid sheet that is required in order for the garment to be repaired. How do we provide pricing for these items or services?
- A2. In lieu of issuing a replacement bid sheet, the Vendor shall provide prices for these items and services in the space below.
